THE COMPETITION WILL BE HELD IN TWO PHASES.

THE PRELIMINARY ROUNDS WILL BE HELD ONLINE FROM 10-11TH MAY.

THE POST-BREAK ROUNDS WILL BE HELD OFFLINE AT THE NLSIU CAMPUS IN THE MONTH OF JULY

THERE ARE THREE SEGMENTS OF THE COMPETITION: NEGOTIATION, MEDIATION (CLIENT-ATTORNEY, MEDIATOR) AND CLIENT COUNSELLING.

THE NEGOTIATION SEGMENT OF THE COMPETITION SERVES AS THE NATIONAL QUALIFIER FOR THE INTERNATIONAL NEGOTIATION COMPETITION (INC) 2026.

ACCORDINGLY, THE HIGHEST RANKING INDIAN TEAM IN THE NEGOTIATION SEGMENT WILL REPRESENT INDIA AT THE INTERNATIONAL NEGOTIATION COMPETITION 2026.

PARTICIPATING UNIVERSITIES WILL HAVE TO APPLY FOR EACH SEGMENT BY TICKING THE APPROPRIATE OPTIONS IN THE PROVISIONAL REGISTRATION FORM.

PROVISIONAL REGISTRATION FOR XI NLS-NMC WILL COMMENCE ON 9TH APRIL, 2025 AND END ON 16TH APRIL, 2025.

POST PROVISIONAL REGISTRATION, THE SELECTED UNIVERSITIES WILL HAVE TO PROVIDE THE DETAILS OF THE PARTICIPATING TEAM MEMBERS FOR EACH SEGMENT AND PAY THE REQUIRED REGISTRATION FEE BY 22ND APRIL, 2025, FAILING WHICH THEIR SLOT WILL BE FORFEITED.

THE SLOTS FOR THE REGISTERED UNIVERSITIES WILL BE INTIMATED VIA EMAIL BY 24TH APRIL, 2025.

THE SEGMENT IS OPEN TO ALL UNDERGRADUATE, PROFESSIONAL AND POSTGRADUATE STUDENTS REGISTERED IN A UNIVERSITY. KINDLY NOTE THAT THE SEGMENT IS NOT LIMITED TO ONLY LAW STUDENTS.

EACH TEAM WILL PARTICIPATE IN 2 PRELIMINARY ROUNDS AGAINST TWO OTHER TEAMS. THE MATCHUPS FOR THE PRELIMINARY ROUNDS WILL BE RANDOM.

AT THE END OF THE PRELIMINARY ROUNDS, THE TOP 8 TEAMS WILL ADVANCE TO THE QUARTER-FINAL ROUNDS, WHICH WILL BE HELD OFFLINE.

THE QUARTER-FINALS AND SEMI-FINALS WILL BE KNOCK-OUT ROUNDS, RESULTING IN THE TOP TWO TEAMS COMPETING IN THE FINALS.

EACH TEAM SHALL CONSIST OF 1 MEMBER ONLY.

THE SEGMENT IS OPEN TO ALL UNDERGRADUATE, PROFESSIONAL AND POSTGRADUATE STUDENTS REGISTERED IN A UNIVERSITY. KINDLY NOTE THAT THE SEGMENT IS NOT LIMITED TO ONLY LAW STUDENTS.

ALL ROUNDS WILL HAVE ONLY ONE MEDIATOR.

THE PARTICIPATING TEAMS WILL BE RANDOMLY MATCHED AGAINST OTHER MEDIATING TEAMS FOR THE PRELIMINARY ROUNDS.

HOWEVER, AS FAR AS POSSIBLE, NO MEDIATOR WILL MEDIATE A ROUND WITH A CLIENT-ATTORNEY TEAM FROM THE SAME UNIVERSITY.

TEAMS FOR THIS SEGMENT WILL CONSIST OF 2 MEMBERS.

THE SEGMENT IS OPEN TO ALL UNDERGRADUATE, PROFESSIONAL AND POSTGRADUATE STUDENTS PURSUING A DEGREE IN LAW FROM AN INDIAN UNIVERSITY.

GIVEN THAT THIS SEGMENT SHALL BE A QUALIFIER FOR THE INTERNATIONAL NEGOTIATION COMPETITION 2026, ALL RULES REGARDING ELIGIBILITY AT THE XI NLS-NMC SHALL BE THE SAME AS ARE APPLICABLE AT THE INC.

EACH TEAM WILL PARTICIPATE IN 2 PRELIMINARY ROUNDS AGAINST TWO OTHER TEAMS. THE MATCH-UPS FOR THE PRELIMINARY ROUNDS WILL BE RANDOM. AT THE END OF THE PRELIMINARY ROUNDS, THE TOP 8 TEAMS WILL ADVANCE TO THE QUARTER-FINAL ROUNDS.
